
You are hereby given notice that the City Council of the City of Haleyville, Alabama, will hold a public hearing at City Hall of said City on the 7th day of July, 2025 at 5:15 p.m. in the Court Room, 911 21<sup>st</sup> Street, Haleyville, AL, for purpose of receiving public comment on the petition to close an undeveloped portion of Fondren Avenue inside the City Limits of Haleyville, Winston County, Alabama. Said portion of Fondren Avenue to be closed is more particularly described as follows:

Beginning at the point where the north right of way of 35<sup>th</sup> Street intersects the west line of Fondren Avenue and the point of beginning of the portion to be vacated; thence north along the west right of way of Fondren Avenue and the east line of Lot 11 of Fondren Heights Subdivision to the North East Corner of said lot; thence east along said Fondren Avenue to the North West Corner of Lot 10 of Fondren Heights Subdivision and the East line of Fondren Avenue; thence south along the West Line of said Lot 10 to the intersection of Fondren Avenue and 35<sup>th</sup> Street; thence West along the north line of 35<sup>th</sup> Street to the point of beginning.



Said portion of Basom Avenue to be closed is more particularly described as follows:

Beginning at the point where the north right of way of 35<sup>th</sup> Street intersects the west line of Basom Avenue [an undeveloped road] and the point of beginning of the portion to be vacated; thence north along the west right of way of Basom Avenue and the east line of Lot 16 of Fondren Heights Subdivision to the North East Corner of said lot; thence east along said Basom Avenue to the North West Corner of Lot 15 of Fondren Heights Subdivision and the East line of Basom Avenue; thence south along the West line of Lot 15 to the intersection of Basom Avenue and 35<sup>th</sup> Street; thence West along the north line of 35<sup>th</sup> Street to the point of beginning.

Said portion of Unnamed Road to be closed is more particularly described as follows:

The segment of street to be vacated, is more particularly described as follows:

BEGIN AT THE NORTHWEST CORNER OF THE NORTHWEST ¼ OF THE SOUTHEAST ¼ OF THE NORTHEAST ¼ OF SECTION 30, TOWNSHIP 9, RANGE 10; THENCE EAST ALONG THE SOUTHERN RIGHT OF WAY OF 33<sup>RD</sup> STREET A DISTANCE OF 481' MORE OR LESS TO THE INTERSECTION OF THE RIGHT OF WAY OF THE UNNAMED ROAD AND THE POINT OF BEGINNING OF THE PORTION OF THE ROAD TO BE VACATED; THENCE CONTINUE EAST FOR A DISTANCE OF 50', MORE OR LESS, TO THE POINT WHERE THE NORTHEAST RIGHT OF WAY OF THE UNNAMED ROAD INTERSECTS THE SOUTHERN RIGHT OF WAY OF 33<sup>RD</sup> STREET; THENCE IN A SOUTHWESTERLY DIRECTION ALONG THE RIGHT OF WAY OF SAID UNNAMED ROAD TO ITS INTERSECTION WITH THE WEST LINE OF THE NW ¼ OF THE SE ¼ OF THE NW ¼; THENCE NORTH ALONG THE WEST LINE A DISTANCE OF 50', MORE OR LESS TO THE NORTH RIGHT OF WAY OF THE UNNAMED ROAD; THENCE IN A NORTHEASTERLY DIRECTION ALONG THE RIGHT OF WAY TO THE POINT OF BEGINNING.
